The data in this EPD has been evaluated on a full-scale life cycle assessment (LCA) study according to ISO 14040/44, taking into account the product category rules (PCR) for electronic and electrotechnical products and systems defined in EN 50693.

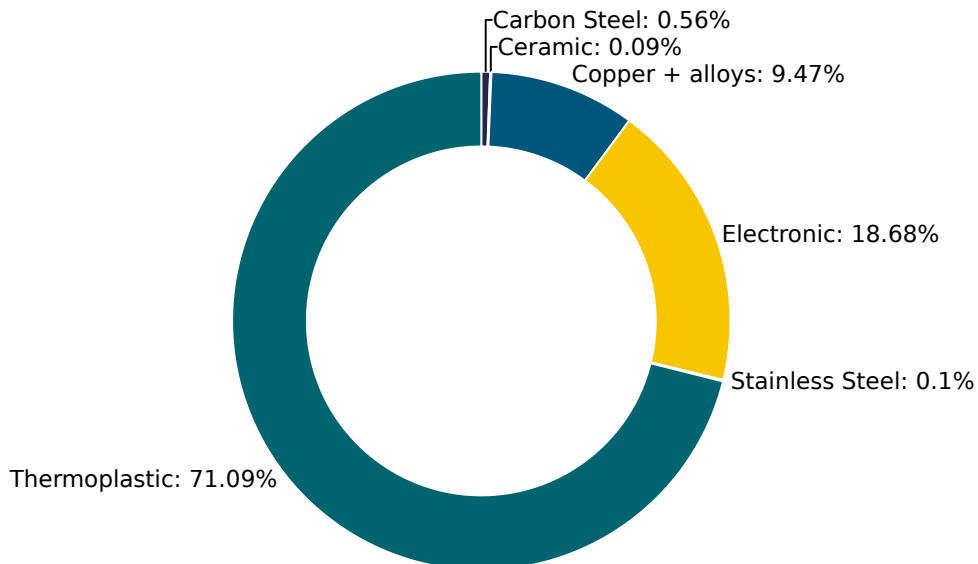

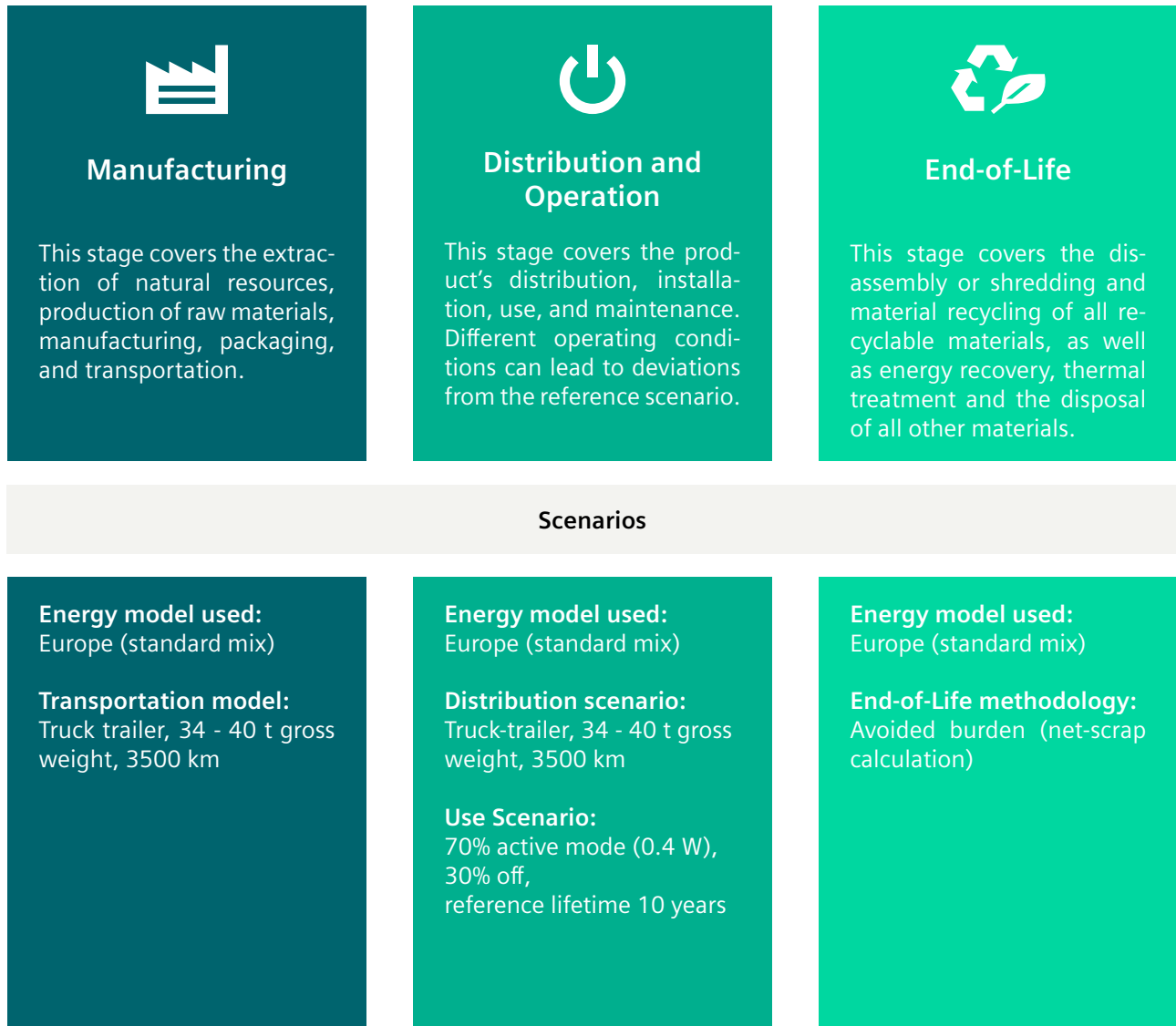
Product Weight 0.3 kg

# Key environmental performance indicators

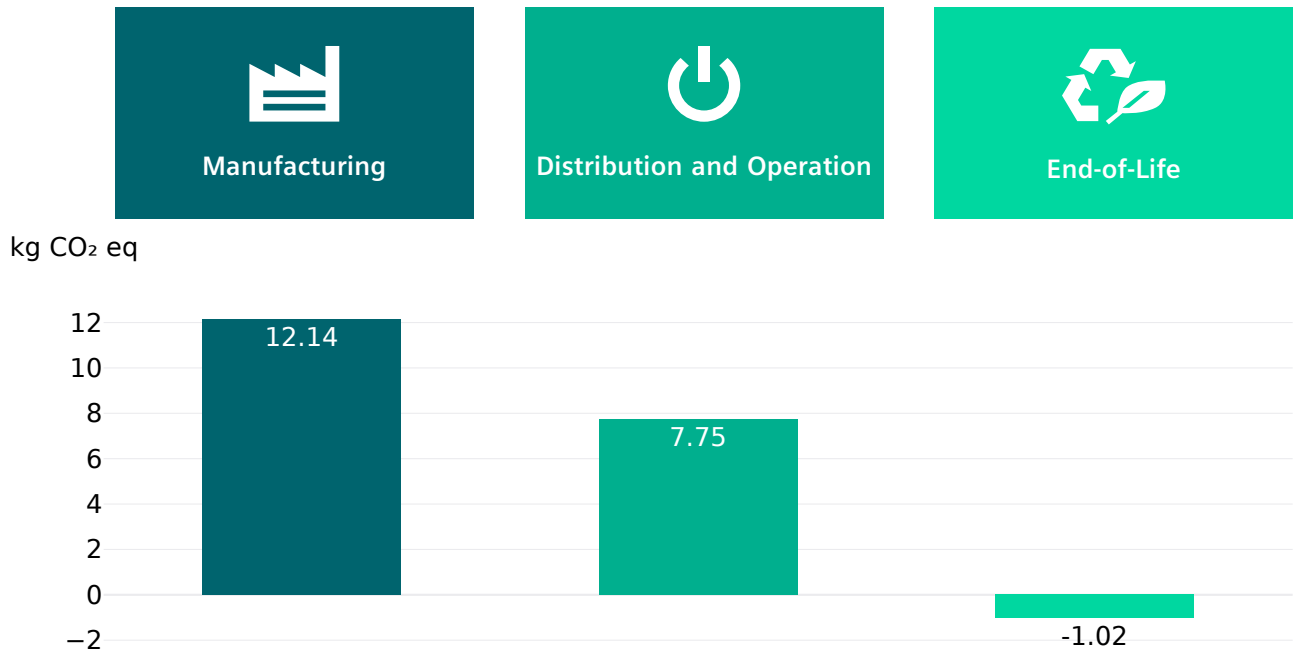

# Climate change

This chart shows the overall impact of the product on climate change – total. Different operating conditions can lead to deviations from the reference scenario. The distribution stage of the reference product is not shown in the chart due to its relatively small contribution to climate change and its impact is included in the operation bar.



## End-of-Life results

The End-of-Life stage was modelled by shredding of the device, followed by sorting and material separation process.



It leads to:

- an overall **product recyclability of up to 14%** mainly due to metal content
- an **energy recoverability of up to 69%** from plastic materials
- a **minimum disposal rate of 17%**

The exact final values depend on the used recycling process and add up to 100%.

**Note:** The device should not be disposed of as unsorted municipal waste. Special treatment for specific components may be mandated by law or recommended for environmental reasons. Observe all local and applicable laws.
