

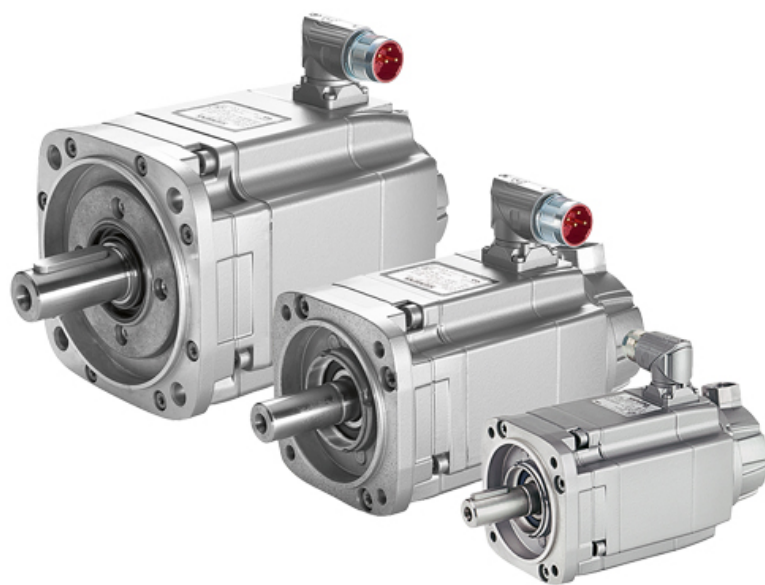

General information

This environmental product declaration (EPD) is based on the international standard ISO 14021 ("Environmental labels and declarations – Self declared environmental claims – Type II environmental labelling"). The data in this EPD has been evaluated on a full-scale life cycle assessment (LCA) study according to ISO 14040/44, taking into account the product category rules (PCR) for electronic and electrotechnical products and systems defined in EN 50693:2019

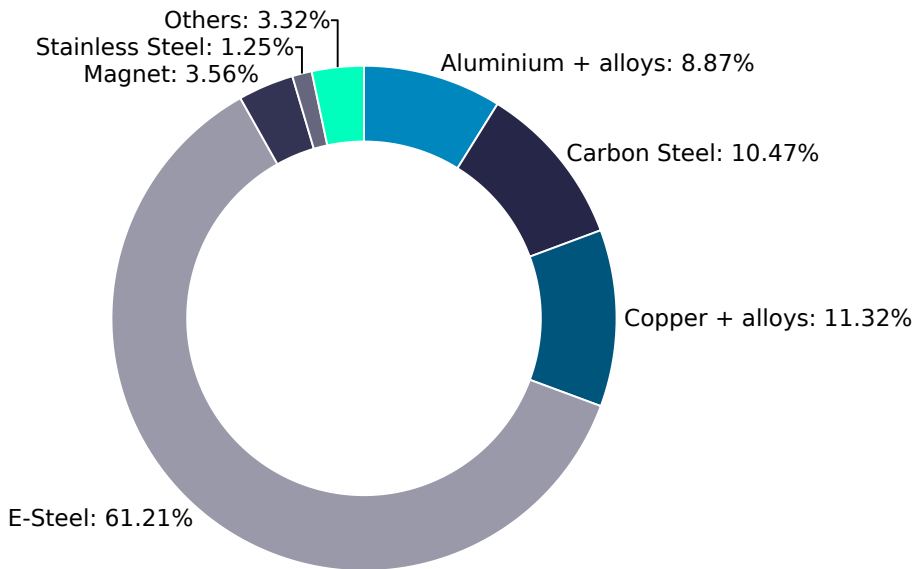

Product Description	SIMOTICS S-1FK7 synchronous motor M0 = 48 Nm; PN = 8,2 kW at nN = 3000 rpm (400 V); without options (e.g. gearbox); inverter operation at 3AC 380 V unregulated infeed.
Functional Unit	Speed and position-controlled motion and torque of a motor over a reference service lifetime (RSL) of 10 years, based on a defined load profile with resulting power losses of 347 W on average ¹

¹ The lifetime value used for calculation is a reference value and does not equate with the minimum, average or real life time.

Material composition

The following chart outlines the overall material composition of the calculated reference product without packaging. Product weight of 38.99 kg adds up with packaging weight of 12.08 kg to a total weight of 51.07 kg. Packaging consists of: Corrugated box, average composition, Wooden pallet (single use), PE film, PP film.

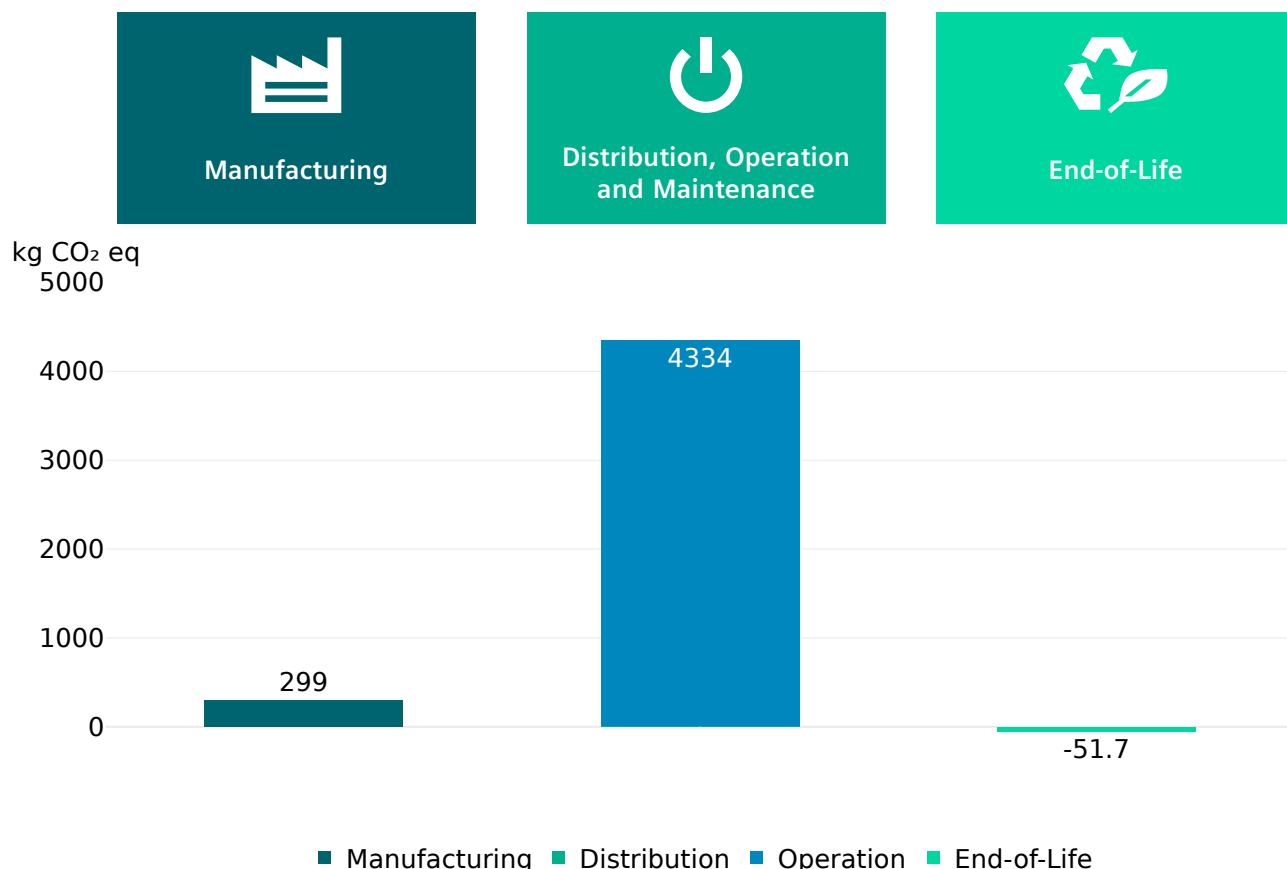

Datasets for resources, such as electrical energy or natural gas, are chosen from the region where the device is produced and assembled. If primary data are not available, secondary data reflecting state-of-the-art manufacturing technology are considered.

Climate change

This chart shows the overall impact of the product on climate change – total. The operations phase is the life-cycle phase with the biggest overall impact. The energy consumption was calculated based on a standardised reference cycle of a feed axis in a machine tool.

Deviations from this reference cycle lead to deviation of the results. The scaling of this reference cycle is based on the performance of the motor (speed/torque) and therefore does not reflect the requirements of a specific application. The energy consumption shown is therefore not suitable for selecting motors for a specific application or comparing them with each other.

End-of-Life results



The end-of-life stage considers the recyclability rates of metal, plastics contents and minimum disposal rates according to the guidelines IEC TR 62635:2012 for end-of-life information provided by manufacturers and recyclers and for recyclability rate calculation of electrical and electronic equipment.

It leads to:

- an overall **product recyclability of up to 88%** mainly due to metal content
- an **energy recoverability of up to 2%** from plastic materials
- a **minimum disposal rate of 11%**

Note: The device should not be disposed of as unsorted municipal waste. Special treatment for specific components may be mandated by law or recommended for environmental reasons. Observe all local and applicable laws.
